PRIVACY

Soccer Without Borders (“the Company”) is committed to maintaining your confidence and trust, and accordingly maintains the following Privacy Policy to protect your personal information. This Privacy Policy explains how we gather, use, and protect the information we receive through our Website, www.soccerwithoutborders.org (the “Website”), donor database (Kindful), as well as any data the Company may collect across partnered and unaffiliated sites and or offline methods.

For purposes of this Agreement, the terms “we,” “us,” and “our” refer to the Company. “You” and “Your” refers to you, as a user of the Website.

CONSENT

By accessing our Website, you accept our Privacy Policy and Terms of Use, and you consent to our collection, storage, use and disclosure of your personal information as described in this Privacy Policy. In addition, by using our Website, or services across partnered and unaffiliated sites, you are accepting the policies and practices described in this Privacy Policy. Each time you visit our website, and any time you voluntarily provide us with information, you agree that you are consenting to our collection, use and disclosure of the information that you provide, and you are consenting to receive emails or otherwise be contacted, as described in this Privacy Policy. Whether or not you register or create any kind of account with us, this Privacy Policy applies to all users of the website and the Service.

INFORMATION COLLECTION

Through the Website, Soccer Without Borders collects two types of information from individuals: Personal Information and Non-Personal Information.

Personal Information which can be defined as information used to uniquely identify an individual. Soccer Without Borders may collect certain personal information from you via the website, when information is provided by you during your communication or transactions with us on the Website and or an affiliated third party site (e.g., making an online donation, submitting an ambassador or volunteer application, and or making a purchase). Examples of information collected include your name, address, billing information, transaction information, phone numbers, and email address. We may also obtain personal information about you from other sources and through other direct communications with you. This includes donations made by mail or through web pages hosted by our various fundraising partners. Additionally, we may obtain Personal Information including details about your browsing or usage session, IP address, Geo-location and/or device unique identifier, details regarding connected third party accounts (such as the e-mail or username for a connected PayPal, Google or Facebook account) and any other Personal Information provided to us by you during your time on our Website.

Non -Personal Information which can be as information that is not uniquely identifying to a specific individual. Soccer Without Borders may collect certain information through Google Analytics and Wix.com regarding your visit to the Website. This information is general and anonymous including information focused on aggregating number of website visits, pages viewed, clicks, and or length of time spent on pages.

HOW WE PROTECT YOUR INFORMATION

Soccer Without Borders takes your privacy concerns very seriously. To that end, only a few select members of the Company staff have access to the limited information we collect through our website. Soccer Without Borders utilizes a number of third party operational platforms including but not limited to Paypal, Qgiv, Kindful, and Constant Contact.

SHARING YOUR INFORMATION

Soccer Without Borders does not sell, trade, or rent your Personal Information. Any information you supply to us will be used for the purpose for which it was given and as otherwise allowed by applicable law. In addition to the kinds of information sharing you might expect, such as sharing with third parties who need your information in order to provide services to us, we may share information: when we believe in good faith that disclosure is necessary to protect our rights or property, protect your safety or the safety of others, investigate fraud or respond to a government, judicial or other legal request, or otherwise to comply with the law. Where release is required by law (for example, a subpoena) or regulation, or is requested by an agency for governmental investigative purposes or governmental proceedings.

COOKIES

Aside from the services provided by Google Analytics and Wix, our web site is not set up to track, collect or distribute personal information not entered by its visitors.
